Re: Public Information Request 18145 40 Dolan

Dear Open Records Division:

The Katy Independent School District received a written request for information from Sean Dolan, a copy of which is attached and labeled "A." In general, the request seeks all emails sent to/from Keith Rowland in 2018. All responsive emails are attached as Exhibit "B." The District seeks a ruling on withholding from public disclosure and asserts that Texas Government Code Section 552.103 (Information Related to Litigation) applies to the information sought.

The ten business day deadline for this letter, pursuant to Tex. Gov't Code Sec. 552.301(b) is August 22, 2018.

As background, during the public comment portion of the District's March 19, 2018 Board Meeting, an individual came forward and levied bullying allegations against the District's Superintendent. While these allegations are unfounded and deal with conduct between teenage boys 40 years ago, the allegations went viral and were included in publications across the United States and even overseas. On May 1, 2018, Sean Dolan also made allegations on his personal website of plagiarism against the District's Superintendent in his doctoral dissertation. His website specifically compared the dissertations of the Superintendent and Keith Rowland and this information was later broadcast to the District employees in a May 2, 2018 email. Exhibit "C." The District and Superintendent shortly thereafter began to consider the appropriate response to such allegations and all avenues for legal recourse. Ultimately, the District authorized the retention of outside counsel to pursue legal action arising from defamation on May 10, 2018. Exhibit "D."

The District requests a determination that Section 552.103 applies to except the requested materials from required public disclosure. The purpose of Section 552.103(a) is to prevent the use of the Public Information Act as a method of avoiding the rules of discovery used in litigation. It excepts from disclosure information that which relates to pending or reasonably anticipated litigation in which the government is a party. See Texas Att'y Gen. ORD 551 (1990). The test for demonstrating this exception applies requires that, as of the date that the request for

information was received by the governmental body: (1) litigation involving the governmental body is pending or reasonably anticipated, and (2) the information relates to the litigation. *Univ. of Tex. Law Sch. v. Tex. Legal Found.*, 958 SW2d 479, 481 (Tex. App. Austin 1997, orig. proceeding.); *Heard v. Houston Post Co.*, 684 SW 2d 210, 212 (Tex. App. Houston 1st Dist. 1984, writ ref'd n.r.e.); ORD 551 at 5 (1990).

The first prong of the test is satisfied because the request for public information was filed after the retention of outside counsel for the specific purpose of defamation litigation. Therefore, as of the date the request for information was received, litigation was already anticipated. The second prong of the test is also satisfied as the requested information relates to the litigation. The request seeks all correspondence to/from Keith Rowland

Having satisfied both prongs of the test, the litigation exception applies. The District requests a determination that Section 552.103 applies to except the requested materials from disclosure under the Public Information Act.

Here is a letter sent to me from a current KISD teacher:

"As a teacher in Katy ISD, and one who recently finished a graduate degree, I cannot sit idly by and not say something in regards to the two dissertations that I've read and studied the last two days. What concerns me most, is Chapter Two of Hindt's dissertation. This is supposed to be a systematic review by the researcher (writer of the dissertation) of several different studies in the field that he will be doing his research. It's extremely important that the researcher do the review of literature himself. For a dissertation, this level-of academic effort is a must!

From my review of both documents, Hindt (2012) appears to have used many of the literature sources that Rowland (2008) researched. Since Hindt's thoughts and connections of these sources are exactly the same, it's highly unlikely that he researched everyone of these studies himself, but instead paraphrased from the 2008 dissertation. If you look closely at both documents, Hindt even presents these ideas in the same order.

I challenge ALL teachers in Katy to do their own research. There is nothing "evil" by reviewing the documents and drawing your own conclusions as to if Hindt has plagiarized his dissertation. And I'll leave you with a thought. If you had written a dissertation and put those hundreds of hours and days into the work, and then were accused of plagiarism, what would you do? Well, I'll tell you what I'd do. I'd put my work next to the one I'm accused of plagiarizing, and ask the public to review it because I'm certain I've done my best work! I think as teachers in this district, we should expect our Superintendent would want us to review his work and vindicate him of a false accusation. I'll warn you however, I was disheartened by what I saw."
