**Re: Request for Public Information Act Opinion  
Katy ISD Public Information Request 18163\_40\_Dolan  
10 Day Letter**

Dear Open Records Division:

The Katy Independent School District received a written request for information from Sean Dolan, a copy of which is attached and labeled "A." In general, the request seeks all 2018 texts and emails from private accounts between all school board members, superintendent, assistant superintendent and general counsel.

The ten business day deadline for this letter, pursuant to Tex. Gov't Code Sec. 552.301(b) is August 24, 2018.

The District believes that the information requested is exempt and privileged from disclosure under sections 552.101 to 552.156 of the Texas Public Information Act, including but not limited to the following exceptions:

**Section 552.101 Confidential Information**

- In conjunction with Sections 418.176 to 418.182 of the Texas Homeland Security Act
- In conjunction with constitutional and common-law privacy
- In conjunction with Texas Rule of Evidence 503

**Section 552.103 Litigation or Settlement Negotiations Involving the State or a Political Subdivision**

**Section 552.107(1) Certain Legal Matters (Attorney Client Privilege)**

**Section 552.111 Agency Memoranda**

- Deliberative Process Privilege
- Work Product Privilege


**Section 552.137 Confidentiality of Certain E-mail Addresses**
