Dear Open Records Division:

The Katy Independent School District received a written request for information from Sean Dolan, a copy of which is attached and labeled "A." In general, the request seeks Raptor sign-in and sign-out information and all communications to or from Lance Hindt, Ashley Vann, Courtney Doyle and Bill Lacey from March 21 to March 26. Responsive information that is not subject to this request for a determination has been provided to Mr. Dolan under separate correspondence.

The ten business day deadline for this letter, pursuant to Tex. Gov't Code Sec. 552.301(b) is Wednesday, October 10, 2018.

The District believes that the information requested is exempt and privileged from disclosure under sections 552.101 to 552.156 of the Texas Public Information Act, including but not limited to the following exceptions:

Section 552.101 Confidential Information

-In conjunction with Texas Rule of Evidence 503

Section 552.107(1) Certain Legal Matters (Attorney Client Privilege)

Section 552.111 Agency Memoranda

-Deliberative Process Privilege

-Work Product Privilege


Section 552.139 Confidentiality of Government Information Related to Security of Infrastructure Issues for Computers
