**Re: Request for Public Information Act Determination

Dear Open Records Division:

The Katy Independent School District received a written request for information from Sean Dolan, a copy of which is attached and labeled "A." In general, the request seeks the record of phone calls made and received from General Counsel Graham, Superintendent Hindt and all sitting board members between February 19 and October 22, 2018.

The ten business day deadline for this letter, pursuant to Tex. Gov't Code Sec. 552.301(b) is November 5, 2018.

The District believes that the information requested is exempt and privileged from disclosure under sections 552.101 to 552.156 of the Texas Public Information Act, including but not limited to the following exceptions:

**Section 552.101 Confidential Information**

-In conjunction with Texas Rule of Evidence 503

**Section 552.103 Litigation or Settlement Negotiations Involving the State or a Political Subdivision**

**Section 552.107(1) Certain Legal Matters (Attorney Client Privilege)**

**Section 552.111 Agency Memoranda**

-Deliberative Process Privilege

-Work Product Privilege


And additionally, also because the information requested is outside the definition of "public information" as defined in Tex. Gov't Code Sec. 552.002(a-2).

Pursuant to Tex. Gov't Code Sec. 552.301(e), the District will submit to the Attorney General by November 12, 2018:

- (a) Written comments stating the reasons why the stated exceptions listed above apply that would allow or require the information to be withheld; and
- (b) A copy of the specific information requested, or representative samples of that information was requested.
